Terms and Conditions

1A) All Bookings that include a Self-Programming Content must submit a copy of Organisation's Public Liability Insurance (min €6.5 Million with specific indemnification of CMETB) with this Form

- 1) **BOOKING FORM** - The booking form must be completed and **signed by the person who is responsible for the booking**. A provisional booking may be made by telephone but we must receive official confirmation within five days.
- 2) **DEPOSIT:**
 - 20% Deposit for All Bookings
 - All deposits must be received before the reservation can be confirmed.
 - **YOUR DEPOSIT IS NON REFUNDABLE**
- 3) **PAYMENT OF BALANCE** - This must be received at least 2 weeks prior to arrival.
- 4) For Residential Bookings to be accepted payment must be made in advance for a minimum of 16 persons. For Day Bookings to be accepted payment for minimum of 8 persons must be made in advance.
- 5) **LATE BOOKING** – A booking made less than three weeks prior to the date of group's arrival, must be accompanied by payment in full amount before booking can be confirmed.
- 6) **CANCELLATION** – Cancellations up to 2 weeks before the arranged arrival date are subject to payment of 50% of the full course fee. Cancellation thereafter will receive no refund. Tanagh OETC reserves the right to change/cancel programmes where the weather dictates.
- 7) **No Show** Maximum of 1 'no show' for every group of 10, otherwise full payment will be required. Final numbers must be confirmed by 10 a.m. on the Friday before the week you come to the Centre.
- 8) **SAFETY** – Group leaders must inform Tanagh OETC of any information relevant to the safety of their group. This includes any illness, injury, special needs or behavioural difficulties. Please note Tanagh OETC staff follow all health and safety procedures however this is an Outdoor Adventure activity which may carry some risk of hurt or injury.
- 9) **UNDERTAKING** – I understand that:
 - The deposit is non-refundable once a place has been confirmed
 - Non compliance with the payment of balance condition (3) above will result in automatic cancellation and forfeiture of deposit.
 - I agree to forfeit all monies if less than 2 weeks notice of cancellation is given.
 - **PERMISSION** - I hereby declare that I have received full Parental/Guardian permission for all members of the above group to participate in the range of activities at Tanagh Outdoor Education & Training Centre.
